
Timetable

2019 is all about growing a community of investors and founders. We are hugely ambitious and want to build the group in a sustainable way such that when we are in a position to start considering deals, we can make a big impact on prospective investee companies. For us, active membership is the first step. Investors who are willing to participate in the group's activities and lend their expertise, adding value beyond any proposed investments are the kind of members we will seek out. The second step is deal flow. Provisionally, the investment opportunities will come in the shape of alumni-founded businesses or companies with alumni on the senior management team as well as start-ups introduced by members of the network who have invested/are investing in the company. We are also in discussion with the University about how we may work together so that the group has the opportunity to support spinouts as well.

Whilst the group will be built around alumni, we are absolutely open to non-alumni and other members of the investor community. Long term, we very much want the group to be a link between St Andrews, and Scotland more widely, and the funding ecosystem here in London.

We are hugely ambitious and want to build the group in a sustainable way such that when we are in a position to start considering deals, we can make a big impact on prospective investee companies.

Having Withers Tech (and their wealth of experience) by our side is invaluable and they will help us to build the network, avoid any regulatory pitfalls and establish a framework to facilitate the network's future investments. Over the coming months, we will look to secure more partnerships that will help us to embed the group within the UK's early stage finance landscape. We welcome any ideas, feedback and introductions from this evening's attendees as we embark on what we hope will be the start of a very memorable journey.
